This Court, having reviewed *Petitioner's Application for Relief under C.R.S. § 6-1-109 For Failure to Respond to Civil Law Enforcement Investigative Subpoena*, and the supporting documents attached therein, and being fully advised in the premises,

HEREBY ORDERS that:

1. Student Loan Help Center shall produce all documents responsive to the State's subpoena within fourteen days of this order pursuant to C.R.S. § 6-1-109(1)(b);
2. The Student Loan Help Center is hereby enjoined from calling Colorado consumers, advertising services, or entering into contracts with Colorado consumers until it fully complies with the State's subpoena; and

3. The Student Loan Help Center shall pay the State's reasonable attorney's fees and costs in connection with this application pursuant to C.R.S. § 6-1-113(4). The State shall submit an affidavit of fees and costs no later than 30 days from the date of this order.
